

Hopkins Township Election Commission Meeting

April 13, 2026

Resolution 2026-14

A motion was made by __Bolser____, supported by __Alberda__ to approve the following resolution for the Election to be held on May 5, 2026.

Upon Voice the motion was carried unanimously.

BE IT RESOLVED, that the Election Commission of Hopkins Township, Michigan hereby authorizes Stacey Timmer, Clerk, to prepare meeting materials for the election commission, secure ballots, precinct supplies, the polling location, and to carry out all other election related duties for the township to conduct all elections, and

BE IT FURTHER RESOLVED, that the Election Commission, hereby provides that absent voter ballots for all Elections to be held in 2026 shall be counted in the precinct of Hopkins Township, and

BE IT FURTHER RESOLVED, that there shall be at least one electronic voting device in the precinct of Hopkins Township, and

BE IT FURTHER RESOLVED, that Stacey Timmer, Clerk is hereby designated as the authorized assistant of this election commission to perform the final inspection on the voting device to be used at this election, and

BE IT FURTHER RESOLVED, MCL 168.679(a) provides the Election Commission, by resolution, provide that at an election at which the ballots are counted and certified at the precinct, one or more additional boards of election inspectors be appointed to serve as receiving boards, and

BE IT FURTHER RESOLVED, the Hopkins Township receiving board is responsible for the duties as outlined in section 168.679(a) of the Michigan Election Law (Article 116 of 1954), and

BE IT FURTHER RESOLVED, the board of the election commission shall appoint two or more election inspectors, with an equal number from each major political party to the Receiving Board prior to each election, and

BE IT FURTHER RESOLVED, that Stacey Timmer, Clerk shall be responsible for scheduling of the required public accuracy test and inspection of the voting device under the supervision of other Allegan County local clerks, on behalf of the Election Commission, present during the Logic and Public Accuracy testing according to the State of Michigan Standards, and

BE IT FURTHER RESOLVED, Stacey Timmer, Clerk shall be allowed to hold the Election at 128 S. Franklin St. Hopkins, MI 49328 in the Hopkins Township and Village hall.

NOW THEREFORE, BE IT RESOLVED, that the persons on the following list are hereby appointed as election inspectors and receiving board officials for said election in the precinct with the highlighted names in the precinct to be the chairperson for the precinct, with the Township of Hopkins authorized to fill vacancies, if any, as provided by law.
